

## CUTTING / BID SPECIFICATION

1. Cutting and maintenance will be done twice a month or as needed depending on season from APRIL 1 thru OCTOBER 31 .
2. Grass in center median area EAST AND WEST bound on GA SR 72 shall be cut and either a combination of CHEMICAL TREATMENT or MANUAL EDGING shall be used to prevent grass from growing OVER EDGES OF CURBING.  
Maintenance and trimming of any existing landscaping will also be required, i.e. existing rose bushes and other small shrubs.
3. Starting at EAST side of CHANDLER RAY ROAD sign on SOUTH SIDE OF GA SR 72 a 33 foot grass cut plus a 4 foot CHEMICAL TREATMENT along Edge of RXR bed extending EAST TO THE PRIVATE RAIL CROSSING.
4. From the private rail crossing EASTBOUND on GA SR 72 cut 16 feet to the edge of the ditch / RXR bed to DAVIS STREET. Trim around STOP SIGN as needed.
5. From DAVIS STREET cut 43 feet to the edge of RXR bed around existing Commemorative.  
crepe Myrtle trees and marble plaques to the OLD ELBERTON ROAD intersection seasonal pruning of CREPE MYRTLES as necessary.  
Use chemicals and/ or edging equipment on both sides of the SIDE WALK and CURBING as necessary.
6. Starting at traffic light EAST BOUND resume 43 cut where applicable to CITY LIMIT.  
boundary some of this stretch includes steep banks covered with thick wild blackberry bushes-keep the bushes trimmed back along edge of existing sidewalk. As before keep both sides of sidewalk trimmed and Treated as necessary.
7. Starting WEST BOUND on GA SR 72 from CITY LIMIT SIGN a 25 foot cut extending from roadway to RIGHT OF WAY (ROW ) post up to home at 10094 HWY 72 WEST.

8. Edge and cut a 4 foot cut on right side of sidewalk in front of 10094 HWY 72 WEST to 2nd CITY LIGHT POLE, then resume a 43 foot cut to property line of the Chevron. Edge and maintain left side of sidewalk and curbing as necessary.
9. Cut and maintain 4 foot swath to right of sidewalk from traffic light WESTBOUND along GA SR 72 to CORNELIA DRIVE / COUNTY LINE edge and maintain left side of sidewalk and curbing as necessary
10. On Glenn Carrie Road NORTH BOUND cut 40 feet on right side of road to property line at 152 Glenn Carrie Road.
11. Starting on the other side of 164 and extending to CITY LIMIT SIGN cut six feet along right shoulder to the creek edge.
12. On GLENN CARRIE ROAD southbound from CITY LIMIT SIGN maintain ROW to house at 257 GLENN CARRIE ROAD. This will include maintenance and trimming of existing landscaping as necessary at HIDDEN FALLS SUBDIVISION ENTRANCE.
13. Starting at RXR CROSSING on OLD ELBERTON ROAD cut right side of road 12 feet to driveway entry at 1451 OLD ELBERTON ROAD keep Privet and encroaching shrubs clear.
14. Starting at PATTON DRIVE to DANIEL STREET on left side cut to ROW Concrete markers a distance of 36 feet plus or minus. Maintain and Edge both sides of sidewalk as necessary.
15. Areas around and back of the CITY HALL BUILDING and around the Fire Station and Civic Club.
